OVERSIZED COMMON CARRIER **Blind & Shades over 90” in width-

Minimum of \$150 intrastate charge and \$225 interstate charge.

Residential delivery \$85 additional surcharge

Magnolia – minimum commercial shipment is \$275 and residential is \$325

Final co. & Paris Texas - \$250 for under 12ft and \$325 for over 12ft. Rods /pole over 94” and less than 106” will be automatically spliced unless specified “DO NOT SPLICE”. For rods 94” to 106” will have a surcharge of \$70 **per box.**

Fabric

Estimated Fabric freight charges of \$3.00 per yard with a \$37.50 minimum charge.

Lining will be charged actual freight with a \$25.00 minimum charge.

The billed amount will be the amount BDD is charged by Fed Ex

Shutters

All shutters not shipped to a B.D.D. location will incur a \$1.00 drop-ship charge per square foot. A residential \$75 charge may apply. The first shutter freight fee is \$70. Each shutter will have an additional \$10 S & H charge whether it will call, drop ship, or installed. Max is \$300 freight

COD Shipping

Any order to be shipped to a customer COD, will be charged \$15.00 in addition to any other shipping and handling charges outlined above.

Expedited Shipping

All orders will be shipped Fed Ex Ground Service or freight line when needed. Any request for expedited shipping will incur additional freight charges i.e.; Overnight or Second Day Air.

BDD Deliveries

B.D.D. will deliver to any dealer within the local delivery area for any orders totaling at least \$200; orders under \$200 will incur a \$15 delivery surcharge. BDD will only deliver to a dealer's ship-to address. We will not deliver to the dealer's customer, installer, or workroom.

Freight Damage

Customers must notify BDD of any freight damage within 8 business days of delivery; any freight damage to shutters must be noted and BDD must be notified within 7 days of receipt. BDD will not be responsible for any freight damage, concealed or visible, if notified after 7 business days. Customer must keep original package for claim and pictures would be appreciated.
